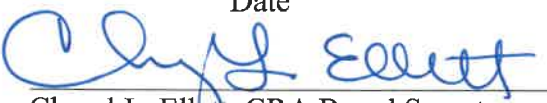

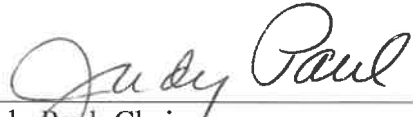
8. ADJOURNMENT
